## State Board of Education Approves New Handbook Resource for Dyslexia

On March 26, 2018, the State Board of Education approved the Arizona Department of Education's (ADE)'s <u>Dyslexia Handbook</u>, a technical assistance document to support families and teachers in educating students with dyslexia.

The newly approved Handbook includes: (1) guidelines for teachers and parents to identify dyslexia; (2) a description of educational strategies that have been shown to improve the academic performance of pupils with dyslexia; and (3) a description of resources and services that are available to pupils with dyslexia and to teachers and parents of pupils with dyslexia.

While dyslexia is not itself an eligibility category under the IDEA, and while not every child with dyslexia will qualify for an IEP, the IDEA regulations specifically reference "dyslexia" as a disorder which *may* result in special education eligibility under the disability category of "specific learning disability." 34 C.F.R. § 300.8(c)(10). Accordingly, if a disability is suspected as a result of a student's dyslexia, the school must conduct an evaluation to determine whether the student qualifies as a child with a disability in need of special education.

The newly published Dyslexia Handbook supplements <u>prior technical</u> <u>assistance</u> issued by ADE last fall, and provides additional tools and resources to schools in meeting the educational needs of students with dyslexia within their student populations.
